

# Live Scan DOJ Accepted Forms Of Identification

## Primary Form of Identification For Live Scan Fingerprinting

*A certified Live Scan fingerprint roller can accept only current, valid, **and** unexpired photo identification documents as the primary form of identification.*

- California or Out of State Driver's License
- State Issued Identification Card
- Department of Motor Vehicles Identification Card
- U.S. Passport or U.S. Passport Card
- Federal Government Personal Identity Verification Card (PIV)
- Uniformed Services Identification Card
- Department of Defense Common Access Card
- Foreign Passport with Appropriate Immigration Document(s) (e.g., Form I-94)
- USCIS – Permanent Resident Card (I-551)
- USCIS – Employment Authorization Card (I-766)
- Federal, State, or Local Government Agency ID Card with Photograph
- U.S. Coast Guard Merchant Mariner Card

## Secondary Forms of Identification Live Scan Fingerprinting

### **(Plus 2 supporting documents required)**

*In lieu of a Primary Form of Identification, an applicant can provide **two** of the following forms of acceptable secondary identification **AND** at least **two** additional forms of supporting documentation listed below this section:*

- State Government Issued Certificate of Birth
- U.S. Tribal or Bureau of Indian Affairs Identification Card
- Native American Tribal Document
- Social Security Card
- Court Order for Name Change/Gender Change/Adoption/ Divorce
- Marriage Certificate (Government Certificate Issued)
- U.S. Government Issued Consular Report of Birth Abroad

- Draft Record
- School ID with Photograph (minimum age 7 years old; otherwise, the transaction will be rejected by DOJ)
- Certificate of Citizenship (N560)
- Replacement Certificate of Citizenship (N-561)
- Certificate of Naturalization (N550)
- Replacement Certificate of Naturalization (N-570)

## **Supporting Documentation for Secondary Forms of Identification (2 forms required)**

*If using a secondary form of identification for your Live Scan Fingerprinting, that form of identification must be accompanied by at least **two** of the following supplemental documents:*

- Utility Bill
- Jurisdictional Voter Registration Card
- Vehicle Registration Card/Title
- Paycheck Stub\*
- Cancelled Check or Bank Statement\*
- Jurisdictional Public Assistance Card
- Mortgage Documents
- Spouse/Parent Affidavit

*\*Financial information can be redacted by the individual and the supplemental document will still be considered acceptable.*

***If the Name and Address on the supplemental documentation do not support the secondary form of identification, then the certified Live Scan fingerprint roller cannot and will not accept the form of identification as valid and will not fingerprint the applicant.***
